SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

HB20-1019 be amended as follows:

- 1 Amend proposed committee amendment (HB1019_L.034), page 1, strike
- 2 lines 1 through 3 and substitute:
 - 3 "Amend reengrossed bill, page 6, strike lines 14 and 15 and substitute
 - 4 "DEPARTMENT OF LOCAL AFFAIRS SHALL CONTRACT WITH A NATIONALLY
 - 5 RECOGNIZED PRISON ACCREDITATION ENTITY TO STUDY FUTURE PRISON
 - 6 BED NEEDS IN COLORADO. WHILE CONDUCTING THE STUDY, THE ENTITY".
- 7 Page 1 of the committee amendment, after line 3 insert:
 - 8 "Page 6 of the bill, strike lines 20 through 22 and substitute:
 - 9 "(b) THE DEPARTMENT SHALL CONVENE AN ADVISORY COMMITTEE
 - 10 THAT CONTAINS THREE REPRESENTATIVES OF LOCAL GOVERNMENTS, OF
 - 11 WHICH AT LEAST TWO MUST BE COUNTY COMMISSIONERS, SELECTED BY
 - 12 THE EXECUTIVE DIRECTOR, FROM EACH COUNTY THAT HAS A PRIVATE
 - 13 PRISON TO CONSULT WITH THE ENTITY DURING THE STUDY."."
- 14 Page 1 of the committee amendment, after line 21 insert:
 - 15 "Page 7 of the bill, line 11, after "SAFETY;" add "AND"."
- 16 Page 1 of the committee report, after line 24 insert:
 - 17 "Page 7 of the bill, line 13, strike "COLORADO; AND" and substitute
 - 18 "COLORADO."
- 19 Page 7 of the bill, strike lines 14 through 17 and substitute:
 - 20 "(c) PRIOR TO COMPLETING THE STUDY, THE DEPARTMENT, IN
 - 21 CONJUNCTION WITH THE COUNTY COMMISSIONERS, SHALL PROVIDE NOTICE
 - 22 AND CONDUCT PUBLIC HEARINGS IN THE COUNTIES IN WHICH PRIVATE
 - 23 PRISONS ARE LOCATED TO ALLOW DIRECT PUBLIC TESTIMONY AND INPUT,
 - 24 WHICH THE DEPARTMENT SHALL INCLUDE IN THE FINAL REPORT."
- 25 Reletter succeeding paragraph accordingly."
