SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB21-148 be amended as follows:

- 1 Amend printed bill, page 6, strike lines 19 through 21.
- 2 Reletter succeeding paragraph accordingly.
- 3 Page 6, line 23, after "ABUSES" insert "PERMITTING THE ACCUSED  
4 BUSINESS THIRTY DAYS TO RESPOND PRIOR TO ANY PUBLIC DISCLOSURE,".
- 5 Page 6, strike line 25 and substitute "AGENCIES TO CONNECT CONSUMERS  
6 WITH EXISTING RESOURCES AND".
- 7 Page 6, strike line 27.
- 8 Page 7, strike lines 1 through 6 and substitute:  
  
9           "(4) THE FINANCIAL EMPOWERMENT OFFICE HAS NO INDEPENDENT  
10 EXAMINATION OR REGULATORY AUTHORITY, BUT NOTHING IN THIS PART  
11 10 SHALL BE CONSTRUED TO LIMIT THE AUTHORITIES OF THE ATTORNEY  
12 GENERAL, THE ADMINISTRATOR DESIGNATED IN SECTION 5-6-103, OR THE  
13 DEPARTMENT OF REGULATORY AGENCIES.  
14           (5) THE DEPARTMENT OF LAW SHALL ANNUALLY REPORT ON THE  
15 STATE OF AFFORDABLE BANKING ACCESS IN COLORADO, THE ACTIVITIES  
16 OF THE OFFICE OF FINANCIAL EMPOWERMENT, AND LOCAL PARTNERSHIPS  
17 IN IMPLEMENTING THE OBJECTIVES OF THE OFFICE AS A PART OF ITS  
18 PRESENTATION TO ITS COMMITTEE OF REFERENCE AT A HEARING HELD  
19 PURSUANT TO SECTION 2-7-203 (2)(a) OF THE "STATE MEASUREMENT FOR  
20 ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT (SMART)  
21 GOVERNMENT ACT". THE REPORT SHALL ADDRESS ACCESS TO SECURE,  
22 SAFE,".
